- How the landscape can create a larger and more useful house.
- How the weather can become an element in design.
- How the DNA of small, carefully crafted houses can be translated into larger buildings and landscape.
- How designing good homes for a few can impact a multitude of families who think they can't afford sunlight, fresh air, and comfortable chairs in their own homes.

The history of modern architecture suggests that the ordinary events of people's lives are the generators of good design. These events might be as simple as sunlight on a chintz tablecloth at breakfast or the glow of a porch light at night. As architects, then, how do we enrich and validate the everyday?

Alan Durning takes a hard look at urban housing and sees what many others have missed. Hidden in city regulations is a set of simple but powerful barriers to affordable housing for all. These rules criminalize history's answers to affordable dwellings: the rooming house, the roommate, the in-law apartment, and the backyard cottage. In effect, cities have banned what used to be the bottom end of the private housing market. They've made urban quarters expensive and scarce, especially for low-income people such as students, seniors, blue-collar workers, artists, and others who make our cities diverse and vibrant.
