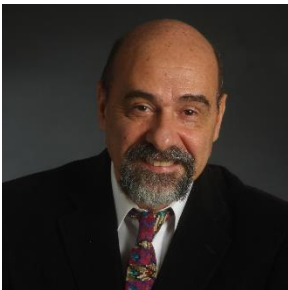

Braitmayer is the founder of Karen Braitmayer, FAIA, Seattle, WA, an architectural consulting firm specializing in accessibility and accessible design. Braitmayer received a BA from Rice University and a Master of Architecture from the University of Houston. Braitmayer served as a member of the Washington State Building Code Council from 1994 to 2001 and remains involved in the development and update of Washington State's accessibility code. In September of 2010, President Obama appointed Ms. Braitmayer to the U.S. Access Board, an independent Federal agency that provides leadership in accessible design under the ADA and other laws.
